Contest Name: PrimoCares ‘Season of Giving’ Judging Contest (the “Contest”).

Contest Dates:

- **Contest Registration and Nomination Period** is scheduled to begin at 12:00:01 am Eastern Time (ET) on 10/21/2022 and ends at 11:59:59 pm (ET) on 12/18/2022 (the “Registration and Nomination Period”).
- **Contest Judging Period** is scheduled to begin on 10/31/2022, (the “Judging Period”) per the Judging schedule below.

Who may Submit Nominations: Nominations may be submitted only by legal U.S. residents of DE, FL, MD, NC, NJ, PA, and SC, who are age 18 or older as of date of entry, and have a valid U.S. driver’s license or government issued photo ID (each an ‘Entrant’), except the following persons who are not eligible to enter or win:

After having read and agreed to these Official Rules, click the submit button to submit your Submission. All Submissions received must be fully complete for all required information. Any Submission with an invalid email address or other incomplete or inaccurate information will be disqualified. **Maximum of one (1) nomination per person and per email address.** In the event an Entrant submits more than one (1) nomination, only the first nomination submitted by the Entrant will be eligible. All Submissions must be received by 11:59:59 p.m. ET on **12/18/2022** to be eligible.

Any incomplete or illegible Submissions will be disqualified. Released Parties are not responsible for lost, late, misdirected, illegible, incomplete, invalid, unintelligible, or damaged Submissions, or for Submissions submitted in a manner that is not expressly allowed under these rules, or for any Submission not submitted or received due to any technical error or failure, unauthorized human intervention, inaccurate capture or mis-entry of any required information, or the failure to capture any such information or effects of hackers or failure of any electronic equipment, computer or cellular transmissions and/or network connections; all of which will be disqualified.

In the event of a dispute as to the identity of any person making a Submission, the authorized account holder of the e-mail address used to register for such action on the Contest website will be deemed to be the registrant and he/she must be eligible according to these Official Rules. The "authorized email account holder" is the natural person assigned an e-mail address by an Internet access provider, online service provider or other organization responsible for assigning e-mail addresses for the domain associated with the submitted address. - Each Photo must be submitted in a file format accepted by the Contest website

Nominees shall be judged pursuant to the following general guidelines, requirements and criteria. Each of the following categories shall represent how the Potential Nominee Winners are determined:

- 50.0%: Quality of Essay
- 50.0%: Emotional Response from Judges

All other entries are disqualified, and ineligible to claim any prize. Potential Nominee Winners are non-transferable.

Decisions of the Administrator and Judges in the selection and determination of Potential Nominee Winners (including any tie -breaker if necessary) and all matters relating to this Contest are final and binding. Each Entrant who nominated a Potential Nominee Winner (each a 'Potential Entrant Winner') will be notified initially by phone beginning on or about the Judging Date as listed above. If the Administrator is unsuccessful in its attempt to reach and speak directly with a Potential Entrant Winner after three (3) attempts over a 24-hour period to the phone number listed on the online registration form for that Entrant, then that Entrant may be disqualified and an alternate Potential Entrant Winner may be determined from the remaining Nominee entries per the judging process procedures outlined above. **Note: messages may or may not be left during the notification process.**

Administrator reserves the right request contact information of Potential Nominee Winner from Potential Nominee Entrant to confirm eligibility and acceptance of prize from Potential Nominee Winner.

If any selected Potential Entrant Winner or Potential Nominee Winner does not meet the eligibility requirements or elects to decline the prize, or Potential Entrant Winner does not provide valid contact information of Potential Nominee Winner as determined by Sponsor, both the Entrant and Nominee will be disqualified and, an alternate grand prize winning Entrant and Nominee will be selected based on the judging process outlined above.
